OVERVIEW

SACE's Working Capital Financial Guarantee (WCFG) allows companies underserved by traditional financing to obtain additional banking financing, improving cash flow to carry out export supply orders. In particular, this product is key for companies dealing with productive and occupational processes not necessarily linked to export and internationalization purposes. SACE's WCFG covers banks from the risk of the debtor's non-reimbursement of the working capital and the relevant interests.

COURSE OBJECTIVES

To provide participants with a clear understanding of the Working Capital Guarantees by focusing on its description and its practical functioning. In particular, this module intends to present the advantages for banks and borrowers, as well as the internal process underlying the issuance of the guarantee. The focus on the work flow will be complemented by an analysis of the Guarantee text's main clauses conducted by SACE specialists and senior underwriters.

As SACE consolidated practice, the module will also encompass the provision of effective guidelines on pricing, paying due attention to the relevant regulatory framework.
