Glossary

Countries are grouped by regions as follows: EU27, Other European countries and Commonwealth of Independent States (CIS), Sub-Saharan Africa, Middle East and North Africa, Americas, Asia and Pacific.

Risk Category:

Country risk level – ranging from 0 to 7, category 0 being considered the minimum risk and category 7 the most - according to the results of the OECD country risk experts group analysis (NC indicates non classified Countries). The risk category is linked to a Minimum Premium Rate for MLT transactions involving sovereign risk. * High income OECD/Euro Area Countries not review or classified (NC*).

Terms of Cover:

SACE's insurance terms of cover in a given country for sovereign, bank and private counterparts.

- Without conditions ("w/o"): no restrictions to SACE's activity.
- With conditions: SACE's activity is subject to some restrictions deriving from international agreements (i.e. IMF Programs' conditionality requirements, and/or OECD's sustainable lending principles).
- With restrictions: SACE's activity on credit risk is limited to transactions with substantial risk mitigating factors (i.e. structured finance or project finance transactions, transactions partly financed by IFIs, regional development bank or other ECAs). Cover for non-credit risks and investment operations (PRI) are also available.
- Off cover: no cover available due to the persistent default in the country and/or lack of safety business conditions.

Sovereign Counterpart:

Transactions with counterparts covered by sovereign guarantee (issued by Ministry of Finance or sub-entities acting on behalf of the State).

Transactions with non-sovereign bank guarantee.

Private Counterpart:

Bank Counterpart:

Transactions with private and non-sovereign corporates.
